Further to our Letter Ref. No. SECY/2017/228 dated 29th April 2017 and with reference to the captioned subject, we wish to inform you that :-

1. The 162nd Meeting of the Board of Directors of the Company was held on Thursday, the 4th May 2017 at Nagpur.
2. The Board of Directors of the Company has considered the recommendations of the Audit Committee of the Company and subject to compliance of certain pre-requisite conditions or approvals, as may be required, has approved the following matters namely :-


